Provinces in Command: Changes in Prefectural Appointments from Hu Jintao to Xi Jinping (2003-2020)

The 'Xi-Li era' in China is characterized by the consolidation of power at the central level and the

strengthening of Party authority. This study aims to examine whether these trends are reflected in local appointment practices since Xi Jinping assumed office in 2013. Through a comparison of the career trajectories of 3,682 prefectural mayors and Party Secretaries during the Hu-Wen and Xi-Li administrations, we have found that while there have been changes in appointment practices, they do not completely align with the narratives of center- and Party-strengthening. Firstly, the developments observed in the Xi-Li era indicate that provincial authorities increasingly make use of prefectural appointments for their own interests, but decisions still maintain a significant influence from the central level. Secondly, evidence to suggest that cadres with a strong Party background have a distinct advantage during the Xi period was not found. Instead, individuals with a proven track record in key functional areas, particularly those with expertise in the economic domain, are still the most likely to attain leadership positions. These findings contribute to the ongoing discourse on the nature of power reconfigurations taking place in Xi's China.

A bargaining and property rights perspective on the Belt and Road Initiative: Cases from the Italian port system

Infrastructure assets play a crucial role in a country's economic and social development. While governments are typically responsible for regulating and managing these assets, multinational enterprises (MNEs) are involved in their development, construction, financing, and operation. The Belt and Road Initiative (BRI) aims to deliver infrastructure projects that bring economic and social benefits to both the host country and the MNEs. However, the success of Chinese MNEs' foreign market entry activities in infrastructure projects is not guaranteed. To understand the factors at play, this paper combine insights from the bargaining power literature with the economics of property rights perspective to examine how host-country actors at different governance levels influence foreign direct investment. Through a comparative case study approach, the paper analyzes four instances where Chinese firms sought to negotiate access to Italian ports. The findings highlight the importance of aligning the various actors involved in the property rights nexus to enable BRI port investments. Chinese investors need to understand the bargaining positions and property rights of actors at multiple levels and across different geographic locations, while also being mindful of changes over time when negotiating infrastructure investments. Host-country governments, on the other hand, should develop a clear port infrastructure strategy to avoid resource wastage in lengthy negotiations and unnecessary infrastructure projects.

'De-risking' not in the interest of EU

The upcoming European Summit in Brussels will discuss various issues, including the Russia-Ukraine conflict, the economy, security and defense, migration, and a strategic discussion on China. This indicates that the EU has yet to make significant changes in its policy towards China as a "partner, competitor, and systemic rival". There is an ongoing debate within the EU regarding its China policy. The COVID-19 pandemic and the spillover effects of the Russia-Ukraine conflict have led to intensified efforts by the United States and some Western powers to demonize China. Consequently, Europe's perception of China has become increasingly negative. Communication and interaction between China and the EU have decreased due to the pandemic, and the Ukraine crisis has further biased the EU against China. The US narrative of "democracy versus authoritarianism" has gained traction in Europe. Enlightened leadership from both China and Europe is needed to eliminate biases and recognize China's role as the worl's secondlargest economy ready to collaborate for the common good. The concept of "de-risking" from and avoiding over- dependence on China has gained popularity in the West, with specific policies targeting China becoming more common. The EU's major economies often indicate the overall direction of the EU's China policy. Despite concerns, some EU countries prioritize their own path instead of aligning closely with the US.

Living Heritage: Guqin
