Health data governance in China: Emphasizing 'sharing' and 'protection' based on the right to health

This article analyzes how China's healthcare sector can adapt its legal framework to effectively govern health data use while balancing public and private interests. Current mechanisms for processing health data, such as individual consent and administrative authorization, are inadequate to meet societal needs and protect individual's interests. The article proposes a shift from individual control to collective governance, where the principle of the right to health can complement this model. This approach emphasizes solidarity, justice, confidentiality, and collective responsibility to balance power asymmetries among stakeholders. The article suggests a solution that combines the state's obligations with private actor's responsibilities, highlighting the importance of data sharing and fair use.


## Index-based analysis of industrial structure and environmental efficiency based on sewage discharge assessment in China

This study used the Moran Index (MI) to explore the relationship between pollution status, financial and economic structure, and spatial characteristics on urban sewage discharge. The results showed that pollution highly correlated with spatial characteristics led to larger urban sewage discharge and worse overall environmental regulation. Regional differences were also found, with cities farther from provincial capitals having lower sewage discharge efficiency. Quantile regression revealed that higher efficiency in urban sewage discharge was associated with greater growth in labor disposable income and GDP.
