- 1) Taxation of capital income and wealth, with focus on issues of efficiency and equity from both theoretical and empirical perspectives.
- 2) Energy poverty, with focus on public policies to reduce it.
- 3) Economics of spectrum management, with focus on spectrum sharing issues.
- 4) Independent regulatory authorities, with focus on those charged with the regulation of energy, water, waste collection and environmental services, communications, transport.
- 5) Digital transformation and data governance of public services, with focus on those provided at municipal level;

Leo Fulvio Minervini has been Assistant Professor of Public Finance at the University of Macerata since 2008. He holds a PhD from the University of Warwick, Warwick Business School (UK).

His major research interests include the economics of public goods and services as well as taxation, the regulation of public utilities, and the political economy approach. His recent research includes energy poverty, taxation of income and wealth, market mechanisms for spectrum sharing, the political economy of economic regulation by independent authorities, health data management.

He has published various works (books, book chapters, articles in national and international journals) mostly on telecommunications, radio spectrum management for wireless services, air transport economics, education, and other public services.
