Title: Long-Term digital preservation of healthcare facilities' archives, public or private. Focus on the current regulatory framework in Italy and Europe, the reference international standards and projects, the requirements to preserve electronic health documents

Offer description:

The research falls within the scope of the scientific collaboration agreement between the University of Macerata and the University of Catania, Department of Electrical, Electronic and Computer Engineering, to realize the UDMA (Universal Document Management Application) project, that aims to develop a system complete and modular to healthcare facilities documents digital preservation. It provide four action lines: 1. Research and analysis of legislation in force in Italy and Europe regarding the digital preservation of records and hybrid archives, producing the national and European regulatory framework on the subject; 2. Research and analysis of the main international standards and projects for digital preservation, producing as a deliverable the synthetic and updated picture of those examined, including indications on the current state, development prospects, strengths and weaknesses; 3. Research and analysis of the typologies of records anche their aggregation produced and preserved by the healthcare facilities, public or private, specifying for each of them: the legal relevance and maintenance needs; the preservation metadata; the requirements regarding access, security and personal data protection; the digital preservation process; 4. Produce a document compliant with italian legislations, named "manuale di conservazione", to give the rules how to execute the preservation process with the system realized in UDMA project.
