**Title:** The Italo-Albanian Protocol and the Detention of Migrants in CPRs: Impact on Security and Local Crime in Albania

### Offer description:

Immigration management in the European Union is a major challenge, with the complications brought about by recent developments in Italy with the signing of the Italy-Albania Protocol 2023. The implementation of the Protocol is bound to have a significant impact on the national security of the Albanian region where the CPRs are located: Albania is a non-EU country and the operation, seen as a possible model of extra-European management of migration flows according to the hotspot approach, raises questions about the effective respect of the fundamental rights of migrants, the potential risk of increased crime and the impact on counter-terrorism strategies. The innovative contribution of the research, within a PNRR project that aims to create safe and inclusive communities, lies in its ability to synthesise and anticipate security spillovers in the territory in which the protocol operates and on the possible increase in crime, offering some useful recommendations to avoid the critical issues highlighted
