













## CALL FOR APPLICATIONS FOR PhD PROGRAMMES CYCLE XXXVI – ACADEMIC YEARS 2020/2023

### Art. 1 Call Issuing

1. The University of Macerata announces a call for applications for the following PhD programmes (cycle XXXVI) – academic years 2020/2023 as follows:

PhD programme in LAW AND INNOVATION
PhD programme in EDUCATION, CULTURAL HERITAGE AND TERRITORIES
PhD programme in GLOBAL STUDIES. JUSTICE, RIGHTS, POLITICS
PhD programme in QUANTITATIVE METHODS FOR POLICY EVALUATION
QMPE1 - Computable General Equilibrium Models and Multisectoral Analysis for Policy Evaluation
QMPE2 - Mathematical and Statistical Methods for Policy Evaluation
QMPE3 - Nowcasting, big data, networks and web scraping
PhD programme in HUMANITIES AND TECHNOLOGIES

- 2. The University of Macerata complies with the European Researchers' Charter and Code of Conduct for the employment of researchers outlined at <a href="https://www.unimc.it/it/ricerca/hrs4r/hrs4r-human-resources-strategy-for-researchers">https://www.unimc.it/it/ricerca/hrs4r/hrs4r-human-resources-strategy-for-researchers</a>.
- 3. According to Ministerial Decree No. 45/2013, research activities being offered are subject to successful recognition on the part of the Italian Ministry of Education, University and Research. Candidates will be informed in case of any negative outcome that should compromise the activation of the courses.
- 4. The selection procedure for the admission to doctoral programmes shall take place in two separate sessions.

At its first session candidates will be selected for:

- positions with scholarship funded by University of Macerata;
- unfunded positions.

As its **second session** candidates will be selected for, where available:

- positions with scholarship funded and co-funded by public and/or private companies for developing specific research topics;
- positions with scholarship funded and co-funded by the Marche Region's programmes, "Eureka" e "Dottorati Innovativi a caratterizzazione industriale", for developing specific research topics;
- positions with scholarship and unfunded positions unassigned in the first session.
- 5. While deadlines for applications are laid down hereby, in Art. 3, the number of available positions and scholarships of the second session will be published after the herein call and updated details shall be posted on the above website.
- 6. Annex A of this Call describes, for each PhD programme, the exam topics, the scientific areas, the assessment criteria, and the interview subjects, as well as any further specific requirements.
- 7. Any positions and scholarships related to the second session shall be awarded according to the selection procedure of the herein call and the awarding of the scholarships for developing specific research topics to the winners shall be subjected to prior endorsement of agreements on part of the funding companies.
- 8. The PhD programmes last three years, from 1<sup>st</sup> November 2020 to 31<sup>st</sup> October 2023. Successful candidates are to participate continuously in training activities which will be necessary to write an independent and original dissertation, and they are encouraged to spend a period of study and research abroad during this same three-year period.

## Art. 2 Admission requirements

- 1. Candidates eligible for PhD programmes are graduates, regardless of gender, age, religion or nationality, holding either an undergraduate degree in compliance with laws existing prior to Ministerial Decree No. 509/99, or a postgraduate degree, or, alternatively, an equivalent qualification issued by a university institution abroad.
- 2. Each applicant has to upload, in the online application, a copy of the holding Italian academic qualifications, or the ones that he/she obtained abroad (both Bachelor's **and** Master's degrees), together with a list of exams that he/she passed, along with relevant translations, where appropriate, into Italian or English language. Such candidates are provisionally admitted to courses and will be excluded from this public selection if their qualification does not fulfil the formal entry requirements of the research programmes.
- 3. Students who expect to obtain their degree by 31/10/2020, or before the derogatory date stated by possibly laws, may submit their application for PhD programmes. In such cases, admission and enrolment are conditional on the truthfulness of their application statement.
  - 4. Additional detailed terms and conditions for admission are provided on Annex A of this Call.

## Art. 3 Application

1. Applications for the first session shall be submitted, either in Italian or in English online only at <a href="https://cfa.unimc.it/2020/01/applicants">https://cfa.unimc.it/2020/01/applicants</a>, no later than 2 p.m. (Italian time) on June 30<sup>th</sup>, 2020, together with a copy of a valid ID (identity card or passport) and the copy of the payment receipt of a non-refundable application fee of € 40.00 via bank transfer, according to the following bank details:

Applications for the second session shall be submitted according to the above mentioned procedure, at <a href="https://cfa.unimc.it/tematicavincolata/2020/01/applicants">https://cfa.unimc.it/tematicavincolata/2020/01/applicants</a>, no later than 2 p.m. (Italian time) on September 3<sup>rd</sup>, 2020 together with a signed copy of a valid identity document and the copy of a valid ID (identity card or passport) and the copy of the payment receipt of a non-refundable application fee of € 40.00 via bank transfer, according to the above mentioned bank details, pointing out the following description in the Subject:

- 2. Under any circumstances, the aforementioned application fees are not refundable.
- 3. An applicant who does not complete the online application by the deadline or who does not state his or her university qualifications or who fails to enclose a signed copy of his or her ID (identity card or passport) or fails to enclose a copy of the payment receipt of the application fee, will be excluded from selection.
- 4. It is not possible to submit more than one application for the same PhD programme, in the same session.
- 5. Applicants who have won the first selection and have enrolled themselves to a Phd programme, cannot apply for the second session, unless they refuse the enrolment relative to the first session.
- 6. To apply for different PhD programmes, the applicant must make separate registrations and submit separate applications, enclosing all required documents and a payment receipt pertaining to each application.
- 7. The applicant must carefully outline a research project proposal (max 14,000 characters, spaces included), as part of the online application, which develops one of the research topics proposed by the chosen PhD programme, available at web page: <a href="https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi.">https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi.</a>
- 8. The research topic that the applicant chooses for his or her application, in the first session, will not necessarily be the topic of the research activity which he or she will carry out in the PhD programme.
- 9. Qualifications, publications and all other required documents must be submitted in PDF format (maximum size for each file is 7 MB) and uploaded as attachments to the online application
- 10. Qualifications, publications and all other required documents must be submitted in PDF format (maximum size for each file is 7 MB) and uploaded as attachments to the online application
- 11. If the application has been correctly transmitted, following submission he/she will receive email confirmation (to his/her registration email address) with the identity code assigned to his/her application. <u>It is not possible to modify or supplement the application after its submission</u>.
- 12. All communication concerning this call is shown on the website <a href="https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi">https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi</a>. Communications pertaining to a single candidate will be sent to the email address which he/she has stated in the application form: so, make sure to type your email address correctly.
- 13. The University will not be held responsible for problems related to technical failure and/or overload of communication and/or information flow, or for its failure to communicate with candidates due to an incorrect email address provided by a candidate, or for any other problem or delay caused by third parties, unexpected occurrences or unforeseeable circumstances.
- 14. The University of Macerata will check the correctness of all applications after the deadline, as stated in the first paragraph of this article. If the application is invalid or excluded, the candidate will be informed via e-mail. The University will also check whether the candidate's statements are true: misrepresentation is a crime under the Italian Criminal Code.

#### **Selection Boards**

- 1. For each of the sessions, Selection Boards are appointed by the Rector and they include university teaching staff and/or researchers. The Chair of each Selection Board is the Coordinator of the relative PhD course or his/her delegate.
- 2. If some scholarships for applied research topics are funded by public and/or private institutions, some representatives of those institutions may participate in the Selection Boards as non-voting consultants, in order to select the best profile for developing the funded research topic.
- 3. The nomination provisions of the Selection Boards will be available at web page https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi.

#### Art. 5 Selection

- 1. The Selection Boards either of the first session and of the second session work by the same procedure, as described below.
- 2. Each application is preliminarily assessed by the Selection Board, which decides if it will or will not be admitted to the following interview step of the selection process, stating a reasoned judgment.
- 3. Results of the aforementioned preliminary assessment, in connection with each PhD course, is published on the admissions website: <a href="https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi">https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi</a>.
- 4. The exam schedule posted on the above website invites candidates who have passed the first selection step into the second interview step. This posting is an official notification to applicants. Candidates are invited to the exam venue, without further notice, on the day and time advertised on the website, and are to bring a valid ID document.
- 5. Because of the restrictions due to Covid-19, the second selection step, in front of the relevant Selection Boards, will be a video conferencing interview, via Microsoft TEAMS, according to the instructions that will be published in the website <a href="https://www.unimc.it/it/dottorato-diricerca/ammissione-ai-corsi">https://www.unimc.it/it/dottorato-diricerca/ammissione-ai-corsi</a>.
- 6. Candidates admitted to the second selection step are interviewed by the Selection Board within the relative PhD course. The Selection Board has the task of checking the applicant's fluency in the languages stated in his/her application.
- 7. The Selection Board **of the second session** will propose the allocation of the scholarships for developing specific research topics, considering the degrees, the skills, experience and approach in relation to the research activity to which the scholarships refer
- 8. At the end of the interview candidates will receive a mark on a scale of 1 to 10, and the selection process will be deemed successful if candidates receive a mark of at least 7 or above. In the event of equal marks, priority will be given to the youngest candidate.
- 9. The final ranking list of successful suitable candidates for each PhD programme is endorsed by Rector's Decree and published on at <a href="https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi">https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi</a>, thereby serving as official notification to applicants.
- 10. The suitable candidates in the number of places established in the competition are declared winners and admitted to the doctoral programme in accordance with the ranking order.
- 11. In the case of successful placement in more than one ranking in the same selection session, the candidate will have to choose a single PhD programme through the enrolment in that one.
- 12 . Winners who obtain a scholarship for applied research activities are required to carry out that specific research topic and must conduct the applied research activity in the funding company or partner organization.

- 13. Winners who already hold research grants are admitted to PhD courses without a scholarship.
- 14. At the end of the selection process, all the candidates will receive a copy of the assessments of their candidacy by the relevant Selection Board, including the outcomes of their initial selections and interviews, in compliance with the principles outlined in the European Researchers' Charter.

## Art. 6 Registration to PhD programmes

- 1. In order to complete enrolment to the PhD programmes, students are required to:
- a) login at <a href="http://studenti.unimc.it./Home.do">http://studenti.unimc.it./Home.do</a> and submit the enrolment form;
- **b)** pay the 1<sup>st</sup> installment of fees (<u>Piano tasse</u>);
- c) send by *PEC* (registered electronic mail) to <a href="mailto:ateneo@pec.unimc.it">ateneo@pec.unimc.it</a>, with object "Concorso di ammissione Dottorato di ricerca ciclo XXXVI", the the documents listed below:
  - Statement of employment status (only Eureka scholarship winners or Dottorato Innovativo scholarship winners)
  - Copy of Tax Code Card
  - Copy of residence permit or copy of application for residence permit (only non-EU citizens)
  - Copy of a health insurance (private or Italian National Health Service) (only non-Italian citizens)
- 2. Applicants with foreign-issued university degrees should also send the following documents so that the University of Macerata can ascertain the equivalency of those degrees to their Italian counterparts:
- copy of the university degree, validated and submitted with an official translation into Italian by the Italian Embassy or Consulate in the country where the degree was issued;
- Dichiarazione di valore validated by an Italian Embassy or Consulate, in the country where the degree was obtained, or alternatively, a Diploma Supplement released according to the model of the European Commission, the Council of Europe and Unesco/Cepes.
- certificate showing all the exams passed in relation to the university degree, including marks, along with its translation into Italian, validated by an Italian Embassy or Consulate in the country where the degree was issued (if you send the Diploma Supplement you do not have to submit the aforementioned certificate).
- 3. The enrolment of a winner entitled to a scholarship, as stated in the final ranking list, must be completed, on penalty of exclusion, within the deadline stated at the bottom of the Rector's Decree endorsing the final ranked list, posted at https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi.
  - 4. The aforementioned winners will not receive any other notice regarding the enrolment deadline.
- 5. <u>If a winner does not enrol within the stated deadline, his/her standing in the Programme will be forfeited.</u>
- 6. If a scholarship winner waives the above entitlement, either expressly or tacitly, the University of Macerata will offer his/her place to the next successful candidate in the final ranking list.
- 7. The enrolment of a winner not entitled to a scholarship must be completed, on penalty of exclusion, within the deadline that the University of Macerata will communicate to him/her exclusively by e-mail.
- 8. Receipt of the enrolment form by the University of Macerata and payment of the tuition and/or fees due, by the deadline, are both necessary for the purpose of accepting the place, on penalty of exclusion.
  - 9. Candidates are never entitled to a refund of tuition and/or fees paid.

## Art. 7 Scholarships and other funding

- 1. Research scholarships each amounting to € 15.343,28 per year are awarded, on the basis of the final ranking of each PhD programme, to candidates who have never previously been awarded a PhD research scholarhip, either wholly or in part. Candidates who are awarded scholarships must register with the Gestione Separata INPS [Separate Contribution of the National Institute for Social Security] in compliance with Art. 2, para. 26 of Law No. 335 of 08/08/1995.
- 2. The amount of a PhD scholarship is increased by 30% for a period of up to 18 months if the holder conducts his/her studies and research activity abroad while on a three-year research course, unless otherwise defined for scholarships co-financed for specific applied research activities.
- 3. PhD scholarships may not be combined with the amount either of research grants or of any other funding, except for funding granted by Italian or foreign institutions for the purpose of additional research or study to be carried out abroad.
- 4. Scholarships are awarded on a yearly basis, and may be renewed, on condition that the student passes his/her exams for admission to the following year, conducted by the Academic Board of the PhD programmes.
  - 5. The scholarship is paid in monthly instalments, at the end of each month.
- 6. Scholarships for specific applied research activities may be awarded by the regional Eureka programme and the regional Innovative Doctorate programme, which involve the participation of the Marche Region and Universities and companies with headquarters in the Marche region. The award of aforementioned scholarships requires specific additional requisites and obligations, which are set out below.

#### A winner awarded a **Eureka scholarship** is required to:

- a) be resident or domiciled in the Marche Region at the time of submitting his/her application form for this call;
- b) be unemployed, according to the Legislation, at the time of submitting his/her application form for this call and for the entire duration of the PhD programme (01/11/2020 31/10/2023);
  - c) attend the lessons in the University for at least 50% of the entire duration of the PhD programme;
  - d) be available to conduct study and research activities abroad for a period not longer than 9 months.

#### A winner awarded a **Dottorato Innovativo scholarship** is required to:

- a) be resident or domiciled in the Marche Region at the time of submitting his/her application form for this call;
- b) be unemployed, according to the Legislation, at the time of submitting his/her application form for this call for the entire duration of the PhD programme (01/11/2020 31/10/2023);
  - c) not be registered in any other university courses in simultaneity with the PhD programme;
  - d) not receive any other funding during the PhD programme;
- e) carry out study and research activities in a company for a minimum period of 8 months and a maximum period of 12 months;
  - f) be available to conduct study and research activities abroad for at least 6 months.
- 7. Requisites and obligations for the granting of other possible scholarships for specific applied research activities, funded by other public or private organizations, will be published online at <a href="https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi">https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi</a>.
- 8. The University of Macerata supports PhD students who are not entitled to a scholarship with funding destined for research activities abroad. Such funding is authorized by the PhD Coordinator or by the Tutor. The maximum available funding equals the highest amount provided for scholarships.

- 9. In line with its yearly budget, the University of Macerata grants all PhD students financial support amounting to 10% of a PhD scholarship, beginning in their second year of enrolment, in order to support study and research activities authorized by the PhD Coordinator or by the Tutor.
- 10. Receipt of a scholarship does not entitle the holder to the status of an employer-employee relationship with the University.

## Art. 8 Regional Grants For Access to Higher Education

Candidates applying to carry out PhD research on the basis of this call may apply for grants issued by *Ente Regionale per il Diritto allo Studio Universitario – ERDIS* (Regional Board for Access to Higher Education), in compliance with its regulations, viewable online at: www.ersumc.it.

### Art. 9 University Fees and Tax

- 1. The maximum amount of tuition and fees due for enrolment in PhD courses is € 1,466.00 per year.
- 2. However, students may apply for tuition reduction on the basis of their ISEE/ISEEU (Financial Revenue Status Index), in accordance with *Regolamento in materia di contribuzione studentesca* (DR no. 256 of 15.07.2019).
- 3. In line with the Stability Law of 2017, para. 262, research students who have not been granted any scholarship are exempted from paying enrolment fees, though they are required to pay the regional tuition for Access to Higher Education, public liability insurance premium and stamp duty.
- 4. As a consequence of the agreement with the Marche Region's funding of the Eureka programme and the Dottorato Innovativo programme, PhD students who have been granted a scholarship from those programmes are exempted from paying enrolment fees, though they are required to pay the regional tuition for Access to Higher Education, public liability insurance premium and stamp duty.
- 5. PhD students listed in Art. 19, para. 11 of the University's Rules and Regulations are exempted from paying tuition, though they are required to pay the public liability insurance premium and the stamp duty.
- 6. A forfeiture following enrolment or dropout from the PhD programme offers no entitlement to any reimbursement of tuition and fees paid.

## Art. 10 Duties of PhD students

- 1. Participation in the PhD programme involves full-time, exclusive commitment by PhD students.
- 2. PhD students cannot enrol simultaneously in any other university course, as laid down by Ministerial Decree No. 271 of 22.10.2004 and following amendments and integrations.
- 3. Public employees who have been admitted to a PhD courses are subject to the provisions of Art. 2 of Law No. 476 of 13.08.84 and following amendments and integrations regulating paid and unpaid study leave. Study leaves are granted on the basis of the needs of the public administration for which the PhD students work and only if they have never enrolled in a PhD course before.
- 4. PhD students are expected to participate in planned activities, except for the instances stated in the University PhD Regulation.
- 5. At the end of each course year, PhD students undergo evaluation by the Academic Board of the PhD programme, which determines whether they will be allowed to continue in the PhD course.
- 6. The Doctor of Philosophy Degree (PhD) is granted upon passing the final examination, which consists in the presentation of a thesis providing significant scholarly results in the chosen field of research. The PhD Thesis, including an abstract in either Italian or English, may be written in Italian, in English or in another language, subject to prior authorization by the Academic Board of the relative PhD course. A report

on the activities carried out during the research course, as well as a list of any published work, should be attached. The final thesis is examined by at least two high-profile university teachers who are not based at any of the institutions awarding the degree (and who may belong to international institutions), chosen on the basis of their scholarly expertise (the evaluators). They provide a detailed written assessment of the final thesis, which can be either approved for oral examination, or rejected if significant additions or corrections are required (in which case the oral examination can be put on hold for a maximum of 6 months). After this period, students are admitted to sit for the final examination, and the same evaluators provide a new assessment, taking into account all the corrections and amendments that have been made. The thesis defence takes place publicly before a Doctoral Degree Conferment Board specifically appointed according to university Rules and Regulations. At the end of the defence, the thesis is either approved or rejected on the basis of a collective written report. The Conferment Board, with unanimous vote, can add an honours commendation to final dissertations of significant scientific relevance.

7. All final theses are stored, in electronic format, in the ministerial database, in the National Libraries of Rome and Florence, and in the Open Access University Digital Archive.

#### Art. 11 Personal Data Processing

- 1. According to 2016/679/UE GDPR, notice is hereby given that the University of Macerata is committed to respecting the confidential nature of the information provided by candidates: all personal data will be processed only for the purposes connected to and instrumental for this call, according to existing laws.
- 2. The Data Controller of personal data is the University of Macerata, with headquarters in Macerata, via Crescimbeni nn. 30-32, in the person of the Provost as Legal Representative.
