Art. 1

Call for application

1. The University of Macerata has announced the following public competition for the selection of candidates for admission to the innovative Ph.D. programme with industrial characterization financed by Marche Region on European Social Fund Plus (public notice for the granting of no. 40 innovative Ph.D. research scholarships with industrial characterization, a.y. 2024/2025, for the four universities in the Marche Region - Decree of the Director of Education, Social Innovation and Sport sector no. 63/IISP of April 29th, 2024 - PR Marche ESF + 2021-2027 Axis 4 OS 4°. DGR N.445 of March 25th, 2024). The Ph.D. programme will last three years, beginning on November 1st, 2024, and ending on October 31st, 2027.

- 4. The University of Macerata complies with the <u>European Charter for Researchers and Code of Conduct for the Recruitment of Researchers</u>.

Art. 2

Admission requirements

- Candidates eligible to partecipate in the present call for applications are those who are inactive, unemployed, in accordance to the relevant regulations in force and to the <u>L.D. no.150 of September 14th</u>, 2015, residents or domiciled in the Marche Region, who have not yet turned 36 years of age.
- 2. Admission requirements at paragraph 1 must be met at the time of the application.
- 3. Applications are sent before the submission deadline from those holding a three-year degree issued prior to the (prior to M.D. no. 509 of November 3rd, 1999) a Master's degree (single-cycle), or a second-level academic qualification issued by institutions belonging to the AFAM (Advanced Artistic and Musical Education) sector, or an equivalent foreign academic qualification (Master's degree) recognised as valid

- for participation by the Admission Committee. Applicants will not be discriminated against on the basis of gender, age, religion, or nationality.
- 4. The suitability of foreign degrees is assessed by the Admission Board, according to the regulations in force in Italy and in the country where the qualification was awarded, as well as treaties or international agreements regarding the recognition of qualifications for the continuation of studies. In such cases, it is necessary to produce copies of the Bachelor's degree and Master's degree diplomas, and copies of the certificates of the examinations taken, accompanied by translations in Italian or English, for each of the above-mentioned degrees.
- 5. All candidates are admitted to the selection with reservations and will be excluded from the selection and the Ph.D. course if, upon verification, it is found that their qualifications do not meet the requirements for admission to Ph.D. courses.
- 6. Applications may also be submitted by those who are awarded their degree in accordance with the provisions in paragraph 1, with the date of enrolment in the doctoral course, and in any case no later than **October 31**st, **2024**. In this case, admission to the application process is conditional and enrolments are regulated by the provisions of Article 6.

Art. 3 Application

- Applications may exclusively be submitted, in Italian or in English language, online at https://pica.cineca.it/unimc/dot-2024-rm/ no later than 12.00 p.m. (Italian time) of October 17th, 2024. Candidates must enclose a copy of a valid identity document (identity card or passport) from which the expiry date of the document can be verified and pay the non-refundable and compulsory application fee of €15, according to the method provided in the telematics procedure.
- 2. Applications that do not follow these guidelines will not be considered.
- 3. Applications that are not completed in full by the admission deadline (art. 3 par. 1), or that fail to include a copy of university degree records (art. 2 par. 3), ID (identity card or passport), the certifications (art.3 par. 8, 9, 10) or the payment receipt of the application fee, will be excluded from the selection process.
- 4. Application fees will not be reimbursed under any circumstances.
- 5. Candidates may submit one application only for the same PhD course. In the event of multiple applications, only the last submission in chronological order, will be considered valid.
- 6. Candidates **must not have previously received a scholarship or partial scholarship** for a Ph.D. programme.
- 7. Applicants must submit a research proposal related to their chosen topic (maximum 13,000 characters including spaces), with specific reference to the epistemological and methodological framework.
- 8. The requirement of unemployment status (art. 2 par. 1) must be certified by <u>Substitutive declaration of certification</u>, pursuant to art. 46 of <u>P.D no. 445 of December 28th, 2000</u>, which must be attached to the application.
- 9. The requirement of unoccupied status (art. 2 par. 1) must be certified by <u>Substitutive declaration of affidavit</u>, pursuant to art. 47 of <u>P.D no. 445 of December 28th, 2000</u>, which must be attached to the application.
- If the candidate is not resident in Marche Region, the domicile requirement (art. 2 par.1) must be attested
 by means of a <u>Substitutive declaration of affidavit</u>, pursuant to art. 47 of <u>P.D no. 445 of December 28th</u>,
 2000, which must be attached to the application.
- 11. Qualifications, publications, and any other required documents must be submitted exclusively in electronic .pdf format and attached to the online application.

- 12. <u>No amendments of additions may be made to the application after it has been submitted</u>. Candidates may only withdraw it and submit a new one with all the mandatory elements, by paying the application fee again, within the same deadline as the one indicated in paragraph 1 of this article.
- 13. The validity of applications will be assessed by the University administration offices after the submission deadline specified in paragraph 1. The University reserves the right to request any additional information deemed necessary. Any false declarations will be subject to prosecution in accordance with current legislation.

- 15. The University does not assume any responsibility for any technical problems, internet issues or service interruptions. If a candidate provides an incorrect email address, the University will not be held liable for any failure to communicate with them. Furthermore, the University will not be held responsible for any problems or delays caused by third parties, unexpected events, or unforeseeable circumstances.

Admission Committee

- 1. The Admission Committees are appointed for each Ph.D. course, upon designation of the Academic Board, by provision of the Rector, and are composed of university professors and/or researchers. The presidency of each Ph.D. admission Board will be held by the Coordinator of the PhD course or by his/her delegate.
- 2. The composition of the Ph.D. Admission Committee will be made available publicly after the deadline of the call, on this webpage https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi/reg-marche/dott-inn40.

Art. 5 Selection

- 1. Admission to the doctoral course will follow a selection procedure based on qualifications and examinations aimed at ascertaining the candidate's preparation, ability, and aptitude for research.
- 2. Each application will be subject to a preliminary assessment and will be declared eligible or ineligible for interview on the basis of the criteria established by the Ph.D. course Admission committee.
- Results of the aforementioned preliminary assessment will be exclusively published, on the webpage https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi/reg-marche/dott-inn40, thereby serving as official notification to candidates.
- 4. Candidates who have been admitted to interview will be examined by the Admission Committee. The Committee will examine and assess the qualifications, skills profile, training, experience, and aptitude relative to the project proposal. The Admission Committee will also ascertain the language proficiency levels indicated in the application form.
- 5. The interviews are conducted exclusively via videoconference, according to the schedule published exclusively on the website at https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi/reg-marche/dott-inn40, along with the link for the online interview.
- 6. The published schedule of interviews is considered an official notification. Therefore, the candidates must regularly check the aforementioned webpage.
- 7. Candidates admitted to the interview must bring a valid ID document during the exam.
- 8. If a candidate does not attend the interview, it will be assumed that they have withdrawn their application from the selection process.

- 9. At the end of the interview, the Ph.D. Admission Committee assigns each candidate a score on a scale from 1 to 10. Candidates who receive a score of 7 or higher will be considered to have successfully completed the interview. In the event of equal scores, priority will be given to the youngest candidate.
- 10. The Admission Committee will formulate merit ranking lists which will be approved by Rectoral Decree and published, **exclusively**, at https://www.unimc.it/it/dottorato-di-ricerca/ammissione-ai-corsi/reg-marche/dott-inn40 as official notification.
- 11. If no suitable candidates or no eligible candidates are identified for the positions advertised of this call for application, the positions will remain unassigned.
- 12. Acceptance of the scholarship is subject to specific requirements and obligations, as set out in the Annexes and in art.8.
- 13. There is no possibility to enrol in a Ph.D. course by withdrawing the scholarship.
- 14. The evaluation judgement, expressed by the Admission Committee in the preliminary assessment and in interview, will be made available to all candidates, at the end of the competition procedures, within the application platform, in accordance with the principles outlined in the <u>European Researchers' Charter</u>.

Enrolment in PhD courses

- 1. Successful candidates **must complete their enrolment no later than October 31th, 2024.** In order to complete enrolment in the doctoral course, selected applicants are required to:
- a) Login at https://studenti.unimc.it./Home.do and complete the enrolment form;
- **b)** Uploading the following documents in the **Attachments section** of the enrolment form:
- Dichiarazione del percipiente (all scholarship winners);
- ISEEU 2024 declaration or ISEE for doctoral course 2024 declarationne ISEE per dottorato di ricerca 2024
 (for all scholarship winners who wish to benefit from the reduction of the second instalment of tuition
 fees)
- Copy of residence permit or copy of the of the request receipt for obtaining a residence permit (non-EU citizens only);
- Copy of a health insurance (private or Italian National Health Service) (non-Italian citizens only).
- c) Proceed with the payment of the first instalment of the PhD. tuition fees and/or contributions (<u>Piano</u> tasse).
- 2. The selected winners will not receive any further notice regarding the enrolment deadline.
- 3. Any failure to complete the enrolment by the deadline will be considered a withdrawal from the selection process.
- 4. Failure to obtain the required degree within the terms established for the entry date, implies non-admissibility to the doctoral programme and, as a result, the inability to proceed with the enrolment.
- 5. The University of Macerata must receive the enrolment form as well as the receipt of payment of due tuition fees in order to confirm scholarship acceptance and enrolment completion. Those candidates failing to fulfil these requirements will be subject to exclusion.
- 6. Fees and/or registration contributions will not be refunded under any circumstances.
- 7. If a scholarship winner expressly or implicitly waives their entitlement, the scholarship will be awarded to the next successful candidate listed in the final ranking list.
- 8. The University of Macerata will notify those concerned of any change in the ranking list and the deadline for taking over via the contact e-mail address indicated in the application.

Further fulfilments for candidates with foreign qualifications

- Winners with admission qualifications obtained in non-EU countries who have not already provided documents for assessing the authenticity and equivalence of the second level qualification obtained when submitting the application (e.g. Diploma Supplement, Declaration of Value issued by the Italian diplomatic authorities in the country where the qualification was obtained, certificate of authenticity and comparability issued by centres such as ENIC-NARIC), will have to provide these documents during the enrolment phase (online in the "Attachments" section) or within two months of the start date of the course.
- 2. The University reserves the right to request a declaration of authenticity and equivalence for qualifications obtained in EU countries, as well as the provision of the original documentation.
- 3. Candidates with foreign qualifications who do not present the required documentation at the time of submission of the application or enrolment process will be provisionally enrolled and will be subsequently excluded from the doctoral course if they fail to provide the requested documentation, or if, upon verification, they do not meet the requirements of art. 2. In such cases, any scholarship payments received must be returned.

Art. 8

Fulfilments and obligations of scholarship recipients

- 1. The Ph.D. student must
 - a. maintain the requirement of unemployment or inactivity throughout the duration of the fellowship benefit (November 1st, 2024 October 31st, 2027);
 - b. attend the course for its entire duration with an exclusive, full-time commitment, regularly following, on the basis of the indications established by the Academic Board and within the terms and in the manner established by the same, the activities envisaged for his/her educational curriculum, devoting himself/herself to individual study programs, in-depth educational study, and the conduct of assigned research activities;
 - c. strictly adhere to the implementation of the assigned topic related to the project accepted for funding, following the instructions of the supervisors, under penalty of revocation of the grant. Any deviation from the funded project must be reported to the Marche Region;
 - d. observe the principles of the Ph.D. regulations of the University of enrollment and generally all current Ph.D. regulations;
 - e. **mandatorily** carry out study and research activities abroad for a period of not less than (six) months;
 - f. **mandatorily** conduct applied research, in one or more companies pertaining to the project partner Cluster, from 6 to 18 months;
 - g. draw up a report on the research project at the end of each year, aimed to continue the activity, countersigned by the supervisors, to be delivered to the Teachers' Board;
 - h. develop, within the three-year period, a research thesis related to the assigned topic.
- 2. The Ph.D. student must not be concurrently enrolled in other university courses.

Art. 9

Scholarships

- 1. The yearly gross amount of the scholarships awarded for attending doctoral courses, set by M.D. no. 247 of February 23rd, 2022 is €16,243.00.
- Scholarship recipients must sign up with INPS Separate Management Registration (Gestione Separata), pursuant to art. 2 par. 26 of the <u>Law n. 335 of August 8th, 1995</u>, and the provisions of art. 4 of Law no. 476 of August 13th, 1984.

- 3. PhD students who, during the three-year doctoral course, intend to carry out paid activities, which do not, in any case, entail the loss of their unemployment or unemployment status, must be authorised by the Board of teachers to attend the course at the same time.
- 4. The scholarship cannot be combined with the payment of research grants, nor with other scholarships of any kind, except those granted by national or foreign institutions useful for integrating training and research activities with stays abroad of fellows.
- 5. The assignment of the scholarship is annual and is confirmed, after passing the verification tests for admission to the following year, by the Academic Board.
- 6. The amount of the scholarship is increased by 50% for carrying out research activities abroad, authorized by the supervisor, for a total period not exceeding twelve months.
- 7. The fruition of the scholarship excludes the establishment of a subordinate employment relationship with the University.

Grants for research activities

 In order to pursue research activities in Italy and abroad, each doctoral student of the National Doctoral Programme is granted an annual budget allowance of up to 20% of the amount of the scholarship, in accordance with Art. 9 co. 4 of M.D. no. 226 of December 14th, 2021.

Art. 11

Tuition fees

- 1. Fees (Regional Fee for the Right to Higher Education, public liability insurance and stamp duty) and the annual fee (Contributo Onnicomprensivo Annuale, COA) for the attendance of the Ph.D. programmes are indicated here: Enrolment and fees (Iscrizioni e tasse).
- 2. The cost of the annual fee (COA) depends on the student's ISEE for the doctoral course (Financial Revenue Status Index), in accordance with the <u>Students' payment guidelines</u> and the <u>Annex</u>.
- 3. Tax exemption, with the exception of civil insurance premium and stamp duty, is granted to individuals with disabilities, with a disability recognition, according to the relevant national regulations, of 66% or more;
- 4. Withdrawal after enrolment or during the Ph.D. course does not entitle the student to a refund of paid taxes and fees.

Art. 12

Personal Data Processing

- In accordance with art. 13 of 2016/679/UE GDPR, notice is hereby given that the University of Macerata is committed to respecting the confidential nature of the information provided by candidates: all personal data will be processed only for the purposes connected to and instrumental to this call, according to existing laws.

 - **d)** Objectives (what does the PhD proposal intend to investigate and/or prove? Why is this line of research original and salient in the field? Why the objectives pursued are relevant for the issue investigated?);
 - **e)** Research Methodology (Is there a particular method that will lead the research? How does it work? Why is this methodology suited?);
 - **f)** Work Plan and Timeline (Provide a six-month outline of how you will complete the work within the time scheduled (the PhD programme takes three years);
 - **g)** References (bibliography used in the state-of the-art and all the relevant sources to explain the proposal).

4) Prove English language proficiency as follows:
