In the next phase, we will develop an action plan at the level of WP that outlines specific implementation steps, together with VR Councils and other related committees/task forces, whenever needed. This plan will be closely aligned with ERUA's long-term sustainability strategy, ensuring that all actions effectively support the alliance's overarching goals and are accompanied by designated resources.

For the purpose of this document, we are using the following definitions:

- **Long-term aspirations:** Broad, forward-looking goals to be achieved over an extended period. It represents a desired future state that reflects an organization's values, ambitions, and purpose.
- **Strategic Policies:** High-level principles established to direct the decision-making and actions in pursuit of the overarching goals.
- **Instruments:** It refers to tools, mechanisms or methods that facilitate the implementation of strategic plans, and help achieve the specific policies and goals.
